## Engine Warranty

**WARRANTY INVALID IF SIGNED COPY OF WARRANTY IS NOT RETURNED TO D & K MOTORSPORTS.**

*PLEASE READ this warranty. If this warranty is not satisfactory, you may return this engine to D & K Motorsports before installation.*

*Warranty period for passenger car and light truck engines is 3 Years, unlimited miles, includes towing and rental vehicle.. If failure of engine should occur during the first 36 months and it is determined that failure is due to a defect in workmanship or parts installed by D & K Motorsports, D & K Motorsports, at its option, will replace or repair defective units to the original buyer.*

*Defective parts sold but not installed by D & K Motorsports will be replaced at no charge, no labor reimbursement will be allowed.*

*Warranty on one-ton chassis and above, commercial, and farm equipment is limited to 2 Years/24,000. Coverage begins on the day the customer accepts delivery. Engine no larger than 8.1L & 8 cylinders. Excludes rental vehicle & towing.*

*Warranty on marine application is 2 Years, unlimited hours. Coverage begins on the day of delivery, includes watercraft up to 65' long & engines no larger than 7.5L (460 CID). I/O drive automotive-type engines within size limitations are eligible. Outboards are NOT eligible. Excludes rental craft or towing.*

*Warranty claims must be approved by D & K Motorsports. ALL DEFECTIVE PARTS MUST BE RETURNED TO D & K MOTORSPORTS. ALL CLAIMS MUST BE ACCOMPANIED WITH A D & K MOTORSPORTS REFERENCE NUMBER.. Reimbursement for labor cost for repairing or replacing a defective part or unit is limited to \$50.00 per hour.*

*D & K Motorsports will not replace alleged defective engine until original engine is returned to D & K Motorsports. D & K Motorsports reserves the right to determine whether to replace the engine or to repair it or the right to repair it themselves.*

*No responsibility will be assumed, and no warranty is given or implied on any engine damaged by improper installation or damaged by failure of any part not supplied by D & K Motorsports. Also installation of high performance parts or accessories shall relieve*

*D & K Motorsports of any responsibility or warranty.*
